# Cyclic Averages of Regular Polygons and Platonic Solids

#### Abstract

The concept of the cyclic averages are introduced for a regular polygon $P_{n}$ and a Platonic solid $T_{n}$. It is shown that cyclic averages of equal powers are the same for various $P_{n}\left(T_{n}\right)$, but their number is characteristic of $P_{n}\left(T_{n}\right)$. Given the definition of a circle (sphere) by the vertices of $P_{n}\left(T_{n}\right)$ and on the base of the cyclic averages are established the common metrical relations of $P_{n}\left(T_{n}\right)$.

## 1. Introduction

Consider a finite set of $n$ points in the plane (space), then locus of points such that the sum of the squares of distances to the given points is constant, is a circle (sphere), whose center is at the centroid of the given points [1, 2].

Denote by $M\left(d_{1}, d_{2}, \ldots, d_{n}, L\right)$ an arbitrary point in the plane (space) of a regular polygon (Platonic solid) of distances $d_{1}, d_{2}, \ldots, d_{n}$ to the vertices $A_{1}, A_{2}, \ldots, A_{n}$, then:

\sum_{1}^{n} d_{i}^{2}=n\left(R^{2}+L^{2}\right) \tag{*}
\end{equation*}
$$

where $R$ is the radius of circumscribed circle (sphere) of the regular polygon (Platonic solid) and $L$ is the distance between the point $M$ and the centroid $O$.

The symmetric equation exists for an equilateral triangle and an arbitrary point $M\left(d_{1}, d_{2}, d_{3}, L\right)$ in the plane of the triangle

3\left(d_{1}^{4}+d_{2}^{4}+d_{3}^{4}+a^{4}\right)=\left(d_{1}^{2}+d_{2}^{2}+d_{3}^{2}+a^{2}\right)^{2} \tag{**}
\end{equation*}
$$

where $a$ is the side of the triangle [8, 11].
The arbitrary point is always considered in the plane of the regular polygon, and in the space of the Platonic solid, respectively.

From relations (*) and (**) follows:

& \sum_{1}^{3} d_{i}^{2}=3\left(R^{2}+L^{2}\right) \\
& \sum_{1}^{3} d_{i}^{4}=3\left(\left(R^{2}+L^{2}\right)^{2}+2 R^{2} L^{2}\right)
\end{aligned}
$$

For a given equilateral triangle, the side $a$ as well as the circumradius $R$ are fixed so that
Theorem 1.1. The locus of points such that

$$
\sum_{1}^{3} d_{i}^{4}=\mathrm{const}
$$

is a circle, center of which is the centroid.
As we see, the distances are considered to the second and the fourth powers. Naturally, we are interested to know what happens if we consider the distances of higher powers.

## 2. Preliminaries

For an equilateral triangle the expression $\sum_{1}^{3} d_{i}^{6}$, contains $\alpha$-the angle between $R$ and $L$, so the locus is not a circle, but for a square case the answer is surprising: the locus of points such that

$$
\sum_{1}^{4} d_{i}^{6}=\mathrm{const}
$$

is a circle.
Generally, the locus is a circle (sphere) if and only if the sum of power distances can be expressed in terms of $L$ and some fixed element (with length) of a given regular polygon (Platonic solid). The fixed element is possible to express in terms of $R$, so we denote such sums by the symbol $\sum_{[R, L]}$, or $\sum_{[R, L]}^{(2 m)}$ to indicate the like powers of the distances.

Denote by $P_{n}(R)$ and $T_{n}(R)$ a regular polygon and Platonic solid, respectively, with an $n$ number of the vertices and circumscribed radius $R$. The value of the $\sum_{[R, L]}$ remains constant when the point $M$ moves on the circle $C(O, L)$ (sphere $S(O, L)$ ). So

Definition 2.1. $\sum_{[R, L]}$-is the sum of like powers of the distances $d_{1}, \ldots, d_{n}$ from an arbitrary point $M\left(d_{1}, \ldots, d_{n}, L\right)$ to the vertices $P_{n}(R)\left(T_{n}(R)\right)$ the value of which is constant for any point of the $C(O, L)(S(O, L))$.

It is clear, the sum of odd power contains radicals and never will be $\sum_{[R, L]}$.

For establishing common properties of the $P_{n}$ and $T_{n}$ discussing average of $\sum_{[R, L]}$ is much preferred

$$
S_{n}^{(2 m)}=\frac{1}{n} \sum_{[R, L]}^{(2 m)} .
$$

Definition 2.2. The cyclic averages $S_{n}^{(2 m)}\left(S_{[n]}^{(2 m)}\right)$ of a regular polygon (Platonic solid) is the average of the sum $\sum_{[R, L]}^{(2 m)}$.

We call such averages the cyclic averages, because as we prove the cyclic averages of equal powers of various $P_{n}\left(T_{n}\right)$ for fixed $R$ and $L$ are the same (if they exist):

$$
S_{n_{1}}^{(2 m)}=S_{n_{2}}^{(2 m)}
$$

if $n_{1} \leq n_{2}$.
On the other hand for any given $P_{n}$ the number of $S_{n}^{(2 m)}$ (as well as $\Sigma_{[R, L]}^{(2 m)}$ ) is defined uniquely, so the number of the cyclic averages is characteristic of the regular polygon.

For example, 2 cyclic averages exist for a regular 3-gon:

$$
S_{3}^{(2)} \quad \text { and } \quad S_{3}^{(4)}
$$

while for a regular 4-gon - 3 cyclic averages:

$$
S_{4}^{(2)}, S_{4}^{(4)} \text { and } S_{4}^{(6)}
$$

They are in relations:

$$
S_{3}^{(2)}=S_{4}^{(2)} \text { and } S_{3}^{(4)}=S_{4}^{(4)}
$$

To demonstrate the efficiency of cyclic averages the analogue of the relation **) will be obtained for the square. Firstly, we turn ( (**) in terms of $R$ and the cyclic averages $-S_{3}^{(2)}, S_{3}^{(4)}$ :

\frac{d_{1}^{4}+d_{2}^{4}+d_{3}^{4}}{3}+3 R^{4}=\left(\frac{d_{1}^{2}+d_{2}^{2}+d_{3}^{2}}{3}+R^{2}\right)^{2},
$$

then replace with

S_{3}^{(2)}=S_{4}^{(2)}, S_{3}^{(4)}=S_{4}^{(4)} \text { and } R=\frac{a}{\sqrt{2}}
$$

we get
Theorem 2.1. For an arbitrary point $M\left(d_{1}, \ldots, d_{4}, L\right)$ in the plane of a square:

$$
4\left(d_{1}^{4}+d_{2}^{4}+d_{3}^{4}+d_{4}^{4}+3 a^{4}\right)=\left(d_{1}^{2}+d_{2}^{2}+d_{3}^{2}+d_{4}^{2}+2 a^{2}\right)^{2}
$$

where $a$ is the side of the square.

## 3. Circle as Locus of Constant $\sum_{[R, L]}$ Sums

Theorem 3.1. For an arbitrary point $M\left(d_{1}, d_{2}, \ldots, d_{n}, L\right)$ in the plane of regular polygon $P_{n}(R)$ :

$$
\sum_{i=1}^{n} d_{i}^{2 m}=n\left[\left(R^{2}+L^{2}\right)^{m}+\sum_{k=1}^{\left\lfloor\frac{m}{2}\right\rfloor}\binom{m}{2 k}\binom{2 k}{k} R^{2 k} L^{2 k}\left(R^{2}+L^{2}\right)^{m-2 k}\right]
$$

where $m=1, \ldots, n-1$.
First we need to prove two lemmas.

Lemma 3.1. For arbitrary positive integers $m$ and $n$, such that $m<n$, the following condition

$$
\sum_{k=1}^{n} \cos \left(m\left(\alpha-(k-1) \frac{2 \pi}{n}\right)\right)=0
$$

is satisfied, where $\alpha$ is an arbitrary angle.
Denote

$$
T=e^{i m \alpha}+e^{i m\left(\alpha-\frac{2 \pi}{n}\right)}+e^{i m\left(\alpha-2 \frac{2 \pi}{n}\right)}+\cdots+e^{i m\left(\alpha-(n-1) \frac{2 \pi}{n}\right)} .
$$

The real part of $T$ is

$$
\operatorname{Re}(T)=\sum_{k=1}^{n} \cos \left(m\left(\alpha-(k-1) \frac{2 \pi}{n}\right)\right) .
$$

The formula of the sum of geometric progression gives

$$
\begin{aligned}
& T=e^{i m \alpha}\left(1+e^{-i m \frac{2 \pi}{n}}+\left(e^{-i m \frac{2 \pi}{n}}\right)^{2}+\cdots+\left(e^{-i m \frac{2 \pi}{n}}\right)^{n-1}\right)=e^{i m \alpha} \frac{1-\left(e^{-i m \frac{2 \pi}{n}}\right)^{n}}{1-e^{-i m \frac{2 \pi}{n}}} \\
& e^{-i m 2 \pi}=\cos (-2 \pi m)+i \sin (-2 \pi m)=1
\end{aligned}
$$

Since $m<n, e^{-i m \frac{2 \pi}{n}} \neq 1$. So $T=0$, i.e. $\operatorname{Re}(T)=0$, which proves Lemma 3.1.
Remark 3.1. If $m \geq n$, the sum always contains $\alpha$.
Lemma 3.2. For arbitrary positive integers $m$ and $n$, such that $m<n$ and for an arbitrary angle $\alpha$ the following conditions are satisfied:
if $m$ is odd

$$
\sum_{k=1}^{n} \cos ^{m}\left(\alpha-(k-1) \frac{2 \pi}{n}\right)=0
$$

if $m$ is even

$$
\sum_{k=1}^{n} \cos ^{m}\left(\alpha-(k-1) \frac{2 \pi}{n}\right)=n \frac{\binom{m}{\frac{m}{2}}}{2^{m}}
$$

When $m$ is odd, using the power-reduction formula for cosine

$$
\cos ^{m} \theta=\frac{2}{2^{m}} \sum_{k=0}^{\frac{m-1}{2}}\binom{m}{k} \cos ((m-2 k) \theta)
$$

we obtain

$$
\begin{aligned}
\sum_{k=1}^{n} \cos ^{m}\left(\alpha-(k-1) \frac{2 \pi}{n}\right)= & \cos ^{m} \alpha+\cos ^{m}\left(\alpha-\frac{2 \pi}{n}\right)+\cdots+\cos ^{m}\left(\alpha-(n-1) \frac{2 \pi}{n}\right) \\
= & \frac{2}{2^{m}}\left[\binom{m}{0} \cos m \alpha+\binom{m}{1} \cos (m-2) \alpha+\cdots+\binom{m}{\frac{m-1}{2}} \cos \alpha\right. \\
& +\binom{m}{0} \cos m\left(\alpha-\frac{2 \pi}{n}\right)+\binom{m}{1} \cos (m-2)\left(\alpha-\frac{2 \pi}{n}\right)+\cdots \\
& +\binom{m}{\frac{m-1}{2}} \cos \left(\alpha-\frac{2 \pi}{n}\right)+\cdots
\end{aligned}
$$

$$
\begin{aligned}
& +\binom{m}{0} \cos m\left(\alpha-(n-1) \frac{2 \pi}{n}\right)+\binom{m}{1} \cos (m-2)\left(\alpha-(n-1) \frac{2 \pi}{n}\right) \\
& \left.+\cdots+\binom{m}{\frac{m-1}{2}} \cos \left(\alpha-(n-1) \frac{2 \pi}{n}\right)\right] \\
& =\frac{2}{2^{m}}\left[\binom{m}{0}\left(\cos m \alpha+\cos m\left(\alpha-\frac{2 \pi}{n}\right)+\cdots+\cos m\left(\alpha-(n-1) \frac{2 \pi}{n}\right)\right)\right. \\
& +\binom{m}{1}\left(\cos (m-2) \alpha+\cos (m-2)\left(\alpha-\frac{2 \pi}{n}\right)+\cdots\right. \\
& \left.\quad+\cos (m-2)\left(\alpha-(n-1) \frac{2 \pi}{n}\right)\right)+\cdots \\
& \\
& \left.+\binom{m}{\frac{m-1}{2}}\left(\cos \alpha+\cos \left(\alpha-\frac{2 \pi}{n}\right)+\cdots+\cos \left(\alpha-(n-1) \frac{2 \pi}{n}\right)\right)\right] .
\end{aligned}
$$

Since $m<n$, from Lemma 3.1 it follows that each sum equals zero, which proves the first part of Lemma 3.2.

When $m$ is even, the power-reduction formula for cosine is

$$
\cos ^{m} \theta=\frac{1}{2^{m}}\binom{m}{\frac{m}{2}}+\frac{2}{2^{m}} \sum_{k=0}^{\frac{m}{2}-1}\binom{m}{k} \cos ((m-2 k) \theta) .
$$

Analogously to the case with odd $m$, the sum of the second addenda vanishes, and since the number of the first addenda is $n$, the total sum equals

$$
n\binom{m}{\frac{m}{2}} 2^{m}
$$

which proves Lemma 3.2.

Proof of Theorem 3.1. We introduce the new notations

$$
A=R^{2}+L^{2} \quad \text { and } \quad B=2 R L
$$

Then

$$
\begin{aligned}
\sum_{i=1}^{n} d_{i}^{2 m}= & (A-B \cos \alpha)^{m}+\left(A-B \cos \left(\frac{2 \pi}{n}-\alpha\right)\right)^{m} \\
& +\left(A-B \cos \left(2 \cdot \frac{2 \pi}{n}-\alpha\right)\right)^{m}+\cdots+\left(A-B \cos \left((n-1) \frac{2 \pi}{n}-\alpha\right)\right)^{m}
\end{aligned}
$$

If $m=1$, by Lemma 3.1 we have

$$
\sum_{i=1}^{n} d_{i}^{2 m}=(A-B \cos \alpha)+\left(A-B \cos \left(\frac{2 \pi}{n}-\alpha\right)\right)+\cdots+\left(A-B \cos \left((n-1) \cdot \frac{2 \pi}{n}-\alpha\right)\right)=n A .
$$

Therefore

$$
S_{n}^{(2)}=R^{2}+L^{2}
$$

If $m>1$, we have

$$
\sum_{i=1}^{n} d_{i}^{2 m}=n A^{m}-\binom{m}{1} A^{m-1} B\left(\cos \alpha+\cos \left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos \left((n-1) \frac{2 \pi}{n}-\alpha\right)\right)
$$

$$
\begin{aligned}
& +\binom{m}{2} A^{m-2} B^{2}\left(\cos ^{2} \alpha+\cos ^{2}\left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos ^{2}\left((n-1) \frac{2 \pi}{n}-\alpha\right)\right) \\
& -\binom{m}{3} A^{m-3} B^{3}\left(\cos ^{3} \alpha+\cos ^{3}\left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos ^{3}\left((n-1) \frac{2 \pi}{n}-\alpha\right)\right)+\cdots \\
& \pm\binom{ m}{m} B^{m}\left(\cos ^{m} \alpha+\cos ^{m}\left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos ^{m}\left((n-1) \frac{2 \pi}{n}-\alpha\right)\right) .
\end{aligned}
$$

According to Lemma 3.2, all sums with the negative sign vanish and only the sums with the positive sign remain.

If $m$ is even

$$
\begin{aligned}
& \sum_{i=1}^{n} d_{i}^{2 m}=n A^{m}+\binom{m}{2} A^{m-2} B^{2}\left(\cos ^{2} \alpha+\cos ^{2}\left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos ^{2}\left((n-1) \frac{2 \pi}{n}-\alpha\right)\right)+\cdots \\
& +\binom{m}{m} B^{m}\left(\cos ^{m} \alpha+\cos ^{m}\left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos ^{m}\left((n-1) \frac{2 \pi}{n}-\alpha\right)\right) \\
& =n\left(A^{m}+\sum_{k=1}^{\frac{m}{2}}\binom{m}{2 k} A^{m-2 k} B^{2 k} \frac{1}{2^{2 k}}\binom{2 k}{k}\right) .
\end{aligned}
$$

If $m$ is odd

$$
\begin{aligned}
& \sum_{i=1}^{n} d_{i}^{2 m}= n A^{m} \\
&+\binom{m}{2} A^{m-2} B^{2}\left(\cos ^{2} \alpha+\cos ^{2}\left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos ^{2}\left((n-1) \frac{2 \pi}{n}-\alpha\right)\right)+\cdots \\
&+\binom{m}{m-1} A B^{m-1}\left(\cos ^{m-1} \alpha+\cos ^{m-1}\left(\frac{2 \pi}{n}-\alpha\right)+\cdots+\cos ^{m-1}\left((n-1) \frac{2 \pi}{n}-\alpha\right)\right) \\
&= n\left(A^{m}+\sum_{k=1}^{\frac{m-1}{2}}\binom{m}{2 k} A^{m-2 k} B^{2 k} \frac{1}{2^{2 k}}\binom{2 k}{k}\right) .
\end{aligned}
$$

Using the floor function (the integer part), the obtained results can be combined into a single formula as follows

$$
\sum_{i=1}^{n} d_{i}^{2 m}=n\left(A^{m}+\sum_{k=1}^{\left\lfloor\frac{m}{2}\right\rfloor}\binom{m}{2 k} A^{m-2 k} B^{2 k} \frac{1}{2^{2 k}}\binom{2 k}{k}\right)
$$

which proves the theorem.
From Theorem 3.1 each sums

$$
\sum_{i=1}^{n} d_{i}^{2 m}, \quad \text { where } m=1,2, \ldots, n-1
$$

are the $\sum_{[R, L]}$ sums. Beginning from the $m \geq n$ all sums of power distances contain $\alpha$ (Remark 3.1).

For example, for $P_{3}$ the sums contain:

- $\cos 3 \alpha$, if $m=3,4,5$;
- $\cos 3 \alpha$ and $\cos 6 \alpha$, if $m=6,7,8$;
- $\cos 3 \alpha, \cos 6 \alpha$ and $\cos 9 \alpha$, if $m=9,10,11$.

Generally for $m \geq n$ the sums $\sum_{i=1}^{n} d_{i}^{2 m}$ contain cosine of the multiples of $n \alpha$. The study of such sums is beyond the scope of this article.

Therefore for $P_{n}$ exist an $n-1$ number of $\sum_{[R, L]}$ sums and if they are constant the locus for each case is a circle:

Theorem 3.2. The locus of points such that the sum of the (2m)-th power of the distances to the vertices of a given $P_{n}(R)$ is constant is a circle, if

$$
\sum_{i=1}^{n} d_{i}^{2 m}>n R^{2 m}, \quad \text { where } m=1,2, \ldots, n-1
$$

whose center is the centroid of the $P_{n}(R)$.

## Remark 3.2.

- If $\sum_{i=1}^{n} d_{i}^{2 m}=n R^{2 m}$, the locus is the centroid of the polygon.
- If $\sum_{i=1}^{n} d_{i}^{2 m}<n R^{2 m}$, the locus is the empty set.


## 4. Cyclic Averages of Regular Polygons

The properties of the cyclic average are as follows:
Property 4.1. Each regular $n$-gon has an $n-1$ number of cyclic averages

$$
S_{n}^{(2)}, S_{n}^{(4)}, \ldots, S_{n}^{(2 n-2)}
$$

Property 4.2. For fixed $R$ and $L$, the cyclic averages of equal powers of various regular $n$-gons are the same:

$$
\begin{aligned}
S_{3}^{(2)}=S_{4}^{(2)}=S_{5}^{(2)}=S_{6}^{(2)}=\cdots, \\
S_{3}^{(4)}=S_{4}^{(4)}=S_{5}^{(4)}=S_{6}^{(4)}=\cdots, \\
S_{4}^{(6)}=S_{5}^{(6)}=S_{6}^{(6)}=\cdots, \\
S_{5}^{(8)}=S_{6}^{(8)}=\cdots,
\end{aligned}
$$

Property 4.3. Any relations in terms of the cyclic averages $S_{n_{1}}^{(2 m)}$, the circumscibed radius $R$ and the distance $L$, which are satisfied for a regular $n_{1}$-gon, are at the same time satisfied for any regular $n_{2}$-gon, where $n_{1} \leq n_{2}$, i.e. $S_{n_{1}}^{(2 m)}$ can be replaced by $S_{n_{2}}^{(2 m)}$.

Eliminate $L$ from the relations of Theorem 3.1 we obtain:
Theorem 4.1. For any regular n-gon:

$$
S_{n}^{(2 m)}=\left(S_{n}^{(2)}\right)^{m}+\sum_{k=1}^{\left\lfloor\frac{m}{2}\right\rfloor}\binom{m}{2 k}\binom{2 k}{k} R^{2 k}\left(S_{n}^{(2)}-R^{2}\right)^{k}\left(S_{n}^{(2)}\right)^{m-2 k}
$$

where $m=2, \ldots, n-1$.
In terms of $S_{n}^{(2)}$ and $S_{n}^{(4)}$ :

Theorem 4.2. For any regular n-gon:

$$
S_{n}^{(2 m)}=\left(S_{n}^{(2)}\right)^{m}+\sum_{k=1}^{\left\lfloor\frac{m}{2}\right\rfloor} \frac{1}{2^{k}}\binom{m}{2 k}\binom{2 k}{k}\left(S_{n}^{(4)}-\left(S_{n}^{(2)}\right)^{2}\right)^{k}\left(S_{n}^{(2)}\right)^{m-2 k},
$$

where $m=3, \ldots, n-1$.
The first two relations of Theorem 3.1 imply:
Theorem 4.3. For any regular n-gon:

$$
\begin{aligned}
& R^{2}=\frac{1}{2}\left(S_{n}^{(2)} \pm \sqrt{3\left(S_{n}^{(2)}\right)^{2}-2 S_{n}^{(4)}}\right), \\
& L^{2}=\frac{1}{2}\left(S_{n}^{(2)} \mp \sqrt{3\left(S_{n}^{(2)}\right)^{2}-2 S_{n}^{(4)}}\right) .
\end{aligned}
$$

The points on the circumscribed circle satisfy

$$
3\left(S_{n}^{(2)}\right)^{2}=2 S_{n}^{(4)},
$$

so
Theorem 4.4. For any point on the circumscribed circle of the regular n-gon:

$$
3\left(\sum_{i=1}^{n} d_{i}^{2}\right)^{2}=2 n \sum_{i=1}^{n} d_{i}^{4}
$$

### 4.1 Equilateral triangle

There are 2 cyclic averages:

$$
\begin{aligned}
& S_{3}^{(2)}=\frac{1}{3}\left(d_{1}^{2}+d_{2}^{2}+d_{3}^{2}\right)=R^{2}+L^{2}, \\
& S_{3}^{(4)}=\frac{1}{3}\left(d_{1}^{4}+d_{2}^{4}+d_{3}^{4}\right)=\left(R^{2}+L^{2}\right)^{2}+2 R^{2} L^{2} .
\end{aligned}
$$

In general case from Theorem 4.1, for $n \geq 3$ [6]

$$
S_{n}^{(4)}+3 R^{4}=\left(S_{n}^{(2)}+R^{2}\right)^{2} .
$$

Denote by the symbol - $\Delta_{(a, b, c)}$ the area of a triangle whose sides have lengths $a, b, c$. Then solution of the system of the cyclic averages is:

Theorem 4.5. For any point $M\left(d_{1}, d_{2}, d_{3}, L\right)$ and $P_{3}(R)$

$$
\begin{aligned}
& d_{1}=d_{1}, \\
& d_{2}^{2}=\frac{1}{2}\left(3\left(R^{2}+L^{2}\right)-d_{1}^{2} \pm 4 \sqrt{3} \Delta_{\left(R, L, d_{1}\right)}\right), \\

& S_{6}^{(10)}=S_{7}^{(10)}=\left(R^{2}+L^{2}\right)^{5}+20 R^{2} L^{2}\left(R^{2}+L^{2}\right)^{3}+30 R^{4} L^{4}\left(R^{2}+L^{2}\right), \\

These systems are simplified for the regular hexagon case only.
The vertices $A_{1}, A_{3}, A_{5}$ and $A_{2}, A_{4}, A_{6}$ form two equilateral triangles, so they satisfy two cyclic relations for $P_{3}$. Generally for $n$-gon if $n$ divisible by 3 :

Theorem 4.9. For any regular $n$-gon, if $n=3 \ell$

There are 8,9 and 10 cyclic averages for the $P_{8}, P_{9}$ and $P_{10}$ cases, respectively. The cyclic averages from the second to the twelfth powers are the same as for regular heptagon, so we write only new ones:

& +560 R^{6} L^{6}\left(R^{2}+L^{2}\right)^{2}+70 R^{8} L^{6}, \\
& +1680 R^{6} L^{6}\left(R^{2}+L^{2}\right)^{3}+630 R^{8} L^{8}\left(R^{2}+L^{2}\right),
\end{aligned}
$$

All three cases $n=8,9,10$ admit further simplifications.
For $P_{8}$ Theorem 4.7 gives:

The vertices $A_{1}, A_{3}, A_{5}, A_{7}, A_{9}$ and $A_{2}, A_{4}, A_{6}, A_{8}, A_{10}$ form two regular pentagons, so they satisfy "additional" cyclic relations for $P_{5}$.

Generally, if $n$ is divisible by 5 :
Theorem 4.12. For any regular $n$-gon, if $n=5 t$

d_{1}^{4}+d_{1+t}^{4}+d_{1+2 t}^{4}+d_{1+3 t}^{4}+d_{1+4 t}^{4}=\cdots & =d_{t}^{4}+d_{2 t}^{4}+d_{3 t}^{4}+d_{4 t}^{4}+d_{5 t}^{4}=5\left(\left(R^{2}+L^{2}\right)^{2}+2 R^{2} L^{2}\right), \\
d_{1}^{6}+d_{1+t}^{6}+d_{1+2 t}^{6}+d_{1+3 t}^{6}+d_{1+4 t}^{6}=\cdots & =d_{t}^{6}+d_{2 t}^{6}+d_{3 t}^{6}+d_{4 t}^{6}+d_{5 t}^{6} \\
& =5\left(\left(R^{2}+L^{2}\right)^{3}+6 R^{2} L^{2}\left(R^{2}+L^{2}\right)\right), \\
d_{1}^{8}+d_{1+t}^{8}+d_{1+2 t}^{8}+d_{1+3 t}^{8}+d_{1+4 t}^{8}=\cdots & =d_{t}^{8}+d_{2 t}^{8}+d_{3 t}^{8}+d_{4 t}^{8}+d_{5 t}^{8} \\
& =5\left(\left(R^{2}+L^{2}\right)^{4}+12 R^{2} L^{2}\left(R^{2}+L^{2}\right)^{2}+6 R^{4} L^{4}\right) .

To summarize the obtained results, we conclude: every regular $n$-gon has an $n-1$ number of cyclic averages, but if $n$ is the composite number we have "additional" relations for the distances, which are obtained from the cyclic averages of the $n_{1}$-gon, where $n_{1}$ is divisible of $n$.

## 5. Rational Distances Problem (Solution for $\boldsymbol{n}=24$ )

Is there a point all of whose distances to the vertices of the unit polygon are rational? The problem has a long history especially for the case of a square. An extensive historical review is given in [7,9, 10]. For case of an equilateral triangle answer is positive [3]. According to [4] open problems are in following cases

n=4,6,8,12 \text { and } 24 .
$$

For $n=6$ - only trivial point is known - the centroid of the unit hexagon.
By Theorem 4.3 the side $a_{n}$ of the regular $n$-gon is:

$$

The right side is the root of the fourth degree polynomial equation with rational coefficients:

thus it is the algebraic number of degree $\leq 4$. On the other hand

$$

is the algebraic number of degree $>4$ [13]. So,
Theorem 5.1. There is not a point in the plane that is at rational distances from the vertices of the unit regular 24-gon.

For positive answers for the $P_{4}$ and $P_{6}$ cases the necessary conditions are the rationalities of the equal areas:

- $\Delta_{\left(d_{1}, \sqrt{2} d_{2}, d_{3}\right)}=\Delta_{\left(d_{2}, \sqrt{2} d_{3}, d_{4}\right)}$, if $n=4$;
- $\sqrt{3} \Delta_{\left(d_{1}, d_{3}, d_{5}\right)}=\sqrt{3} \Delta_{\left(d_{2}, d_{4}, d_{6}\right)}$, if $n=6$.


## 6. Sphere as Locus of Constant $\sum_{[R, L]}$ Sums

For regular polygons with different vertices the number of the $\sum_{[R, L]}$ sums are different too. As we see, unlike the plane case, dual Platonic solids have the same number of the $\sum_{[R, L]}$ sums:
regular tetrahedron:
octahedron and cube:
icosahedron and dodecahedron: $\quad \sum_{[R, L]}^{(2)}, \sum_{[R, L]}^{(4)}, \sum_{[R, L]}^{(6)}, \sum_{[R, L]}^{(8)}, \sum_{[R, L]}^{(10)}$.
To prove these, we consider each Platonic solid separately. In all cases, we consider solids centered at the origin and use simple Cartesian coordinates.

### 6.1 Regular Tetrahedron

The coordinates of the vertices $T_{4}(R)$ :

Consider an arbitrary point in space $M\left(d_{1}, d_{2}, d_{3}, d_{4}, L\right)$ with the coordinates: $(x, y, z)$. The distance between $M$ and the centroid $O$ of the tetrahedron:

Theorem 6.1. The locus of points in the space such that the sum of the fourth power of the distances to the vertices of a given regular tetrahedron is constant is a sphere whose center is the centroid of the tetrahedron.

## Remark 6.1.

- If $\sum_{1}^{4} d_{i}^{4}=4 R^{4}$ the locus is the centroid.
- If $\sum_{1}^{4} d_{i}^{4}<4 R^{4}$ the locus is the empty set.

The sums of the distances of the power more than 4 contain $x, y$ and $z$ (like $\alpha$ for the plane case), so for $T_{4}$ only the sums of the second and fourth powers are $\sum_{[R, L]}$ sums.

### 6.2 Octahedron and Cube

The coordinates of the vertices of the octahedron $T_{6}(R)$ :

Theorem 6.2. For an arbitrary point in the space, the sum of the quadruple of the distances to the vertices of the cube which lie on parallel faces and are endpoints of skew face diagonals, satisfies

## Remark 6.3.

- If $\sum_{1}^{n} d_{i}^{2 m}=n R^{2 m}$ the locus is the centroid.
- If $\sum_{1}^{n} d_{i}^{2 m}<n R^{2 m}$ the locus is the empty set.

The center of the sphere is the centroid of the icosahedron (dodecahedron).

## Remark 6.4.

- If $\sum_{i=1}^{n} d_{i}^{2 m}=n R^{2 m}$ the locus is the centroid.
- If $\sum_{i=1}^{n} d_{i}^{2 m}<n R^{2 m}$ the locus is the empty set.


## 7. Cyclic Averages of Platonic Solids

Summarize the obtained results, in terms of the cyclic averages:
Theorem 7.1. The cyclic averages of the Platonic solids are the following:
$S_{[4]}^{(2)}=S_{[6]}^{(2)}=S_{[8]}^{(2)}=S_{[12]}^{(2)}=S_{[20]}^{(2)}=R^{2}+L^{2}$,

S_{[6]}^{(6)}=S_{[8]}^{(6)}=S_{[12]}^{(6)}=S_{[20]}^{(6)}=\left(R^{2}+L^{2}\right)^{3}+4 R^{2} L^{2}\left(R^{2}+L^{2}\right), \\
S_{[12]}^{(8)}=S_{[20]}^{(8)}=\left(R^{2}+L^{2}\right)^{4}+8 R^{2} L^{2}\left(R^{2}+L^{2}\right)^{2}+\frac{16}{5} R^{4} L^{4}, \\
S_{[12]}^{(10)}=S_{[20]}^{(10)}=\left(R^{2}+L^{2}\right)^{5}+\frac{40}{3} R^{2} L^{2}\left(R^{2}+L^{2}\right)^{3}+16 R^{4} L^{4}\left(R^{2}+L^{2}\right)

Eliminate $L$ and $R$ from the relations, we obtain direct relations among the cyclic averages of the Platonic solids.

Theorem 7.2. For each Platonic solid ( $n=4,6,8,12,20$ ):

S_{[n]}^{(8)} & =\frac{1}{5}\left(9\left(S_{[n]}^{(4)}\right)^{2}+12 S_{[n]}^{(4)}\left(S_{[n]}^{(2)}\right)^{2}-16\left(S_{[n]}^{(2)}\right)^{4}\right), \\
S_{[n]}^{(10)} & =S_{[n]}^{(2)} S_{[n]}^{(4)}\left(9 S_{[n]}^{(4)}-8\left(S_{[n]}^{(2)}\right)^{2}\right)
\end{aligned}
$$

Like the plane cases, in some space cases we have "additional" relations. Each Platonic solid, except the tetrahedron satisfies Theorem 4.7 and for the cube and the dodecahedron Theorem 6.2.

For the radius of the circumscribed sphere and the distance between the point and the centroid:

Theorem 7.5. For each Platonic solid ( $n=4,6,8,12,20$ ):

$$
\begin{aligned}
R^{2} & =\frac{1}{2}\left(S_{[n]}^{(2)} \pm \sqrt{4\left(S_{[n]}^{(2)}\right)^{2}-3 S_{[n]}^{(4)}}\right) \\
L^{2} & =\frac{1}{2}\left(S_{[n]}^{(2)} \mp \sqrt{4\left(S_{[n]}^{(2)}\right)^{2}-3 S_{[n]}^{(4)}}\right)
\end{aligned}
$$

The points on the circumscribed sphere satisfy

$$
4\left(S_{[n]}^{(2)}\right)^{2}=3 S_{[n]}^{(4)},
$$

so

Theorem 7.6. For any point on the circumscribed sphere of each Platonic solid ( $n=4,6,8,12,20$ ):

$$
4 \sum_{1}^{n} d_{i}^{2}=3 n \sum_{1}^{n} d_{i}^{4} .
$$

## 8. Conclusion

In the present paper, we introduce the $\sum_{[R, L]}$ sums and define the cyclic averages of the regular polygons and the Platonic solids. We prove the main property of the cyclic averages - the equality of them for various regular polygons and Platonic solids. By means of the cyclic averages the distances of an arbitrary point to the vertices of the regular polygons (the plane case) and the Platonic solids (the space case) are investigated. All cases of constant sum of like powers of the distances, when the locus is a circle (a sphere), are found. General metrical relations for regular polygons (Platonic solids), which were known in special cases only, are established. Rational distances problem solved for the $n=24$ case.
